

## **ONE MORE TEAM COMPETITION ("THE COMPETITION")**

### **TERMS & CONDITIONS**

1. Information on how to enter the Competition forms part of the terms and conditions of entry. Entry into the Competition or acceptance of any portion of the prizes are deemed as acceptance of these Terms and Conditions.
2. New Zealand Rugby Union Incorporated, PO Box 2172, Wellington 6140, is the promoter of this competition ("**the Promoter**").
3. The Competition is not in any way sponsored, endorsed or administered by, or associated with, Facebook, Instagram or Twitter. Any queries, comments or complaints about the Competition must be directed to the Promoter and not to Facebook, Instagram or Twitter. In participating in the Competition you are providing information to the Promoter and not to Facebook, Instagram or Twitter. To the extent permitted by law, you agree to release Facebook, Instagram and Twitter from any and all claims and demands arising out of or in connection with your participation in the Competition or with any of the prizes offered.

### **ELIGIBILITY**

4. The Competition seeks to reward a school or club that has successfully registered one (or more) eligible Rugby Team(s) for the 2016 as compared with the 2015 season.
5. You may only enter the Competition if you are over 18 years of age and sufficiently authorised to enter on behalf of an eligible Rugby Team (as defined below at clause 6).
6. An eligible Rugby Team is a 2016 school or club Rugby team that:
  - (a) consists of 15 or more players;
  - (b) has completed the New Zealand Rugby school or club Rugby team registration form, either in paper form or in the National Rugby Database; and
  - (c) is not a duplicate of another 2016 Rugby team at that school or club, ("**an eligible Rugby Team**").

### **Participation in the Competition**

7. The Competition commences Tuesday, 1 September 2015 07:00am (NZT) and closes Saturday, 30 April 2016 at 10:00pm (NZT) ("**the Competition Period**"). Any entry received after the end of the Competition Period will be ineligible to enter the Competition.
8. To enter the Competition within the Competition Period, you must complete and submit your online entry form found at the competition website <http://sporty.co.nz/onemoreteam> ("**the Competition Website**"). The entry is complete when you receive a confirmation email from the Promoter with the details of your entry ("**the Entry**"). If you do not receive a confirmation email, you have not entered the Competition.
9. There is a limit of one (1) Entry per eligible Rugby Team during the Competition Period. A school or club is entitled to one entry for every team that they register



in the 2016 Rugby Season over and above what they registered in the 2015 Rugby Season.

**Example:** School team A registered 10 teams in the 2015 Rugby Season. School team A has registered 13 teams in the 2016 Rugby Season. School team A is eligible to make three (3) entries into the Competition.

10. You acknowledge and agree that the Promoter can share details of the Entry through digital and social media channels as the Promoter sees fit irrespective of whether the Entry is a winning Entry or not, without compensation to you or your Team.

## THE COMPETITION

11. Details of the competition will be communicated via the Competition Website.
12. The grand prize winners will be selected by the Promoter on 1 May 2016 or such other date as advised by the Promoter.
13. There will be at least four (4) winners of the grand prize will be selected by the Promoter. The Promoter reserves the right to select more winners if appropriate.
14. Following selection of the grand prize winners, the Promoter will contact all of the winners within 48 hours of the selection. If the Promoter, having used reasonable efforts, is unable to contact a grand prize winner within 48 hours of contact being made via the contact details provided in the Entry, then the prize is forfeited and a new winner will be chosen by the Promoter.

## Grand Prize

15. Four (4) grand prize winners will win a visit from two (2) or more players from the 2016 All Blacks squad to their school or Club for one (1) hour duration ("**the Grand Prize visit**").

The Promoter will determine the following:

- (a) the All Blacks players who will attend the visit;
- (b) when the visit will take place including, but not limited to, the date, time and length of the visit;
- (c) the format that the visit will take including cancellation or rescheduling of the visit if the Grand Prize visit cannot be delivered for reasons outside of the Promoter's control; and
- (d) the groups or individuals who can attend the visit e.g. authorised media.

The grand prize winners will be responsible for providing:

- (a) the Promoter with a key contact person to facilitate the Grand Prize visit;
- (b) a suitable area for the All Blacks visit to take place. This will include a fine weather option (a field or other suitable large outdoor space) and a wet weather option (a hall or large indoor space). Any option will need to be approved by the Promoter.



16. All grand prize winners agree to the Promoter sharing details of their Entry through the social media channels of the Promoter and announcing them as a grand prize winner (including but not limited to their Team name and details of the school or club Entries) for no compensation whatsoever.
17. The Promoter reserves the right to:
  - (a) to verify the validity of the Entries received;
  - (b) disqualify any Entry which does not comply with these Terms and Conditions and select a replacement winner;
  - (c) to substitute the grand prize in whole (or any of its components), with a substitute prize if the Grand Prize visit (or any of its components) cannot be provided for reasons outside the Promoter's reasonable control.
18. The Grand Prize visit is non-transferable and non-exchangeable.
19. The Promoter's decision is final and no correspondence will be entered into.
20. The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to or alteration of Entries into the Competition. The Promoter assumes no responsibility for any injury or damage to entrants or any other person's computer related to or resulting from participation in, or down-loading any materials in relation to the Competition. The Promoter reserves the right to disqualify any entrant who tampers with any of the Competition processes or engages in conduct that may damage the reputation of the Promoter or its affiliated entities at any time.
